### **Conditions of Sale**

1. The Canine puppy is sold for the amount of R\_\_\_\_\_.
2. The Breeder guarantees that the Canine puppy has been screened/evaluated by a veterinarian and that all required vaccination courses applicable has been administered. A copy of the vaccination records shall be provided to the Buyer.
3. The Breeder guarantees that the Canine puppy has been issued with a genealogy certificate and that this will be provided to the new owner.
4. The breeder acknowledges that all aspects of the Canine puppy have been discussed with the Buyer and that no information is withheld from the Buyer.
5. The Buyer agrees to notify the breeder if he cannot keep the Canine puppy for any reason during its lifetime. The Breeder will assist in placing the canine puppy in another mutually acceptable home.
6. The Buyer agrees that he will never place the Canine puppy, or its offspring, if decided to breed with the animal, at any shelter, pound, pet store or public-sales situation.
7. The Canine puppy may not be sold or given away by the Buyer without written consent of the Breeder, who shall have the right of first refusal.

### **Health Certification**

1. To the best of the Breeders knowledge, the Canine puppy is free from signs or symptoms of disease or any congenial defects as of the date the puppy leaves the Breeder.
2. The Buyer agrees to have the Canine puppy examined by a registered practicing veterinarian within 72 hours after receiving the animal.
3. The Buyer shall notify the breeder immediately if any medical illness is identified during the veterinarian examination.
4. The buyer shall produce a medical report issued by the veterinarian that undertook the examination and hand the Canine puppy back to the Breeder within five days of the date of purchase.
5. The Breeder would refund the Buyer the full amount paid or would replace the Canine puppy at its sole discretion.
6. The breeder will not be liable for any illness that develops after the first five days after purchase.
7. The puppy is guaranteed until one year of age against genetic/congenial defects, which would cause death or the need to humanely destroy. In such an unlikely case, a written report by a registered practicing veterinarian is required. The puppy will be replaced or the original purchasing price will be refunded at the sole discretion of the Breeder.
8. The Buyer would be responsible for the cost of the veterinary examination and all transportation cost to and from the Breeder.
